- 1. Letter of support for Landscapes of Injustice: All present are in favour Lillian sending the letter.

- 2. Finances: Charlotte deposited cheque from CDF. Next time Charlotte sees Lillian they will sign direct deposit form and get that set up.
 - a. Action items: Charlotte will contact RBC about adding Karen as a signatory and Karen will go to the bank and sign the paperwork.
- 3. Yukon Words request about collaborating for Black History Month:
 - a. All present are in favour of finding out more information, seems like a good partnering opportunity.
 - b. Action item: Paul to email them back and get more information.
- 4. Midori presents current financial balance sheet: Deposits are a \$10 membership fee in December and the CDF grant. No expenses other than banking fees.
- 5. Website:
 - a. Paul reviews a document he has prepared, see end of minutes for a copy.
 - b. Board would like to look into adding capability to pay membership fees and a donation button.
 - c. Charlotte: concern that if we solicit advertising it may compromise our non-profit status. Would need to look into this.
 - d. Paul clarifies a goal of the new website is to have it mobile ready.
 - e. Paul: thinking about creating an Asian and Black history timeline.
 - f. Paul: maybe we could put Peggy's regular discoveries on social media. Action item: Peggy to look into permissions for reusing newspapers.com articles. Karen is willing to help with keeping social media page updated.
 - g. Paul: Our profiles are still relevant and we could build more. Other people or groups could create their own profiles. Profiles are a major part of the website.
 - h. Discussion on title "digital resources" no one is really tied to it.
 - i. Questions about what we have permission to do with some of our materials (recordings, etc.) can we put them online?
 - j. Action item: Board to provide feedback on Paul's doc by January 14.
- 6. Upcoming CDF grant application: deadline is next Friday. Would be great if we could submit an application for Peggy to do more research to support website and social media feeds. Next application time is May. Action item: Karen, Peggy, Lillian, and Charlotte may liaise about this over the weekend.
